30 days prior to hearing session - Registration	
2 weeks following completion of Topic 17 hearing - All Parties file written Closing Remarks**	
2 weeks prior to Closing Remarks (Topic 18) hearing session - <b>Deadline for persons and/or organizations who are not Registered Interveners to file their written comments **</b>
